Each year, families who wish to apply for tuition assistance must complete the following:

- 1. Complete the FLCS Application for Tuition Assistance Form and return to the high school office.
- 2. Complete the FACTS application online: Log onto Family Portal, click "Financial" on the left side menu. In the Financial Links box, there will be a link that says, "Apply for Grant & Aid".
 - Pay the FACTS \$35 application fee online.
 - Collect all required documentation (listed below) and submit to FACTS.

______ I understand that both steps #1 and #2 above must be completed before my application will be considered. All paper applications must be received in the office by June 15, 2023. The online portion must be completed and allow enough time for FACTS to process by June 15, 2023.

Once you have submitted your online application, application fee, and all required documentation, your application will be reviewed and analyzed by FACTS to determine financial need.

Tuition assistance funds from FLCS are limited. Families foreseeing financial need should prayerfully explore all possible sources of alternative funding. To be considered for tuition assistance, a student must be in good standing both academically, financially, and in citizenship.

The following information is REQUIRED for FACTS to process your application:

- Copies of your 2022 Federal tax forms, including all supporting tax schedules. (1040 or 1040EZ)
- Copies of 2022 W-2 or 1099 for both parents / guardians.
- Copies of supporting documentation for social security income, welfare, child support, food stamps, worker's compensation and TANF.

AWARDS APPLY TO TUITION ONLY, NOT REGISTRATION, BUS FEES, CLASS & ATHLETIC FEES, ETC.

2023 - 2024 Application for Tuition Assistance

The Forest Lake Christian School ("FLCS") Application for Tuition Assistance requires considerable family, spiritual, and financial information which is used to make informed decisions regarding tuition assistance. The information provided to FLCS will be kept confidential and will be used only by those who are determining awards. To apply for tuition assistance from FLCS, the following **two** applications must be completed and submitted **by June 15, 2023**.

- Forest Lake Christian School Application for Tuition Assistance (attached)
- FACTS online application

Requirements for Tuition Assistance

Please initial on each line to indicate agreement and understanding with each item:

- 1. One parent of the student(s) must be a professing Christian and active in a local church.
- 2. The student must desire to attend FLCS, demonstrate excellent character, and display good citizenship. If student behavior does not meet good citizenship criteria, tuition assistance will be immediately withdrawn.
- 3. The student should be achieving academically at the "C" level or above in all subjects and/or classes. If a student receives an "F" in any subject or class on a report card, tuition assistance will be withdrawn.
- 4. Students must be punctual to school and have a good attendance record. Tuition assistance will be withdrawn for students who are frequently tardy or absent.
 - 5. Parents and students must publicly support the school board, administration, and employees in their verbal and written communication, including comments on social media. If communication or comments are made that would negatively impact the school or its employees, tuition assistance will be immediately withdrawn and the family will not be allowed to apply for tuition in assistance in the future.
- 6. Parents and students must support and uphold Forest Lake Christian School's Moral Foundations and Standards Policy, in their verbal and written communication.

Policies for Tuition Assistance

In submitting this application, parents understand and agree that:

- 1. Determination of tuition assistance awards are at the sole discretion of FLCS.
- 2. FLCS designates a percentage of its budget toward providing financial aid for families. It is anticipated that there will be more applicants who meet the requirements for assistance than there are funds available, therefore families who are qualified may not receive assistance.
- 3. Families who receive tuition assistance are asked to provide volunteer work at FLCS.
- 4. Each family will be required to pay a portion of tuition for the school year. The maximum award is 50% off tuition for returning FLCS families and 10% off tuition for families who are new to FLCS.
- 5. Tuition assistance awards are for one school year and are for tuition only. Assistance is not provided for registration fees, bus fees, athletic participation fees, books and any other school fees or payments.
- 6. Forest Lake Christian School does not discriminate on the basis of race, color, national or ethnic origin in the administration of its tuition assistance programs, educational policies, admissions policies, and athletic and other school administered programs.
